Officer/Coordinator/DR Announcements and Reports

Chairperson. Kathy thanked everyone who is cycling out of their AIS positions. They have provided great service to AIS, particularly in the time of COVID. Kathy also thanked Karen for all the work she is doing on Founders Day. In addition, Kathy emphasized the need to fill open positions and noted that many of the positions do not require that much time.

Treasurer. In addition to her written report for January, Sue reported the following: (1) groups have been generous in January with donations and the purchase of literature; (2) the report concerning AIS's personal property has been submitted to the Pima County Assessor's Office; and, (3) Storage King is increasing its price by \$3 a month to cover the

cost of insurance. Sue also stated that at Founders Day she will speak about service the need to fill open positions.

DR for District 24. Julia reported that she has had good participation by her GRs. She is also involved in business meetings to give the delegate to the WSO guidance concerning the alignment on how groups are starting meetings as set out in the Service Manual.

DR for District 20. Ricki reported that the web page was correct about meetings in District 20. She is having difficulty finding GRs for all the groups. She has almost served 3 years in her position and is concerned that there is no one to take over—service beyond the group level is "nil."

Literature Coordinator. Frank reported that it has been a pleasure serving in this position during COVID. There have been good literature sales for January. WSO is reporting that the Service Manual will be available at the end of February, but WSO has previously reported when the Service Manual will be available but then not met the stated timeline.

Meeting List Coordinator. Steve is going to propose service as a topic at the group meetings he attends. There was also discussion of having the Concept read the 3rd week of the month because service is covered in the Concepts.

Other Matters of Note.

Mike M reported that that he will be sending out a flyer regarding the opportunity to carry the Al-Anon message to those incarcerated in the Men's Prison located on south Wilmont.

Marta reported that there would soon be a flyer with more information regarding the summer convention.

Kathy closed the meeting at 7:45 p.m. with the Al-Anon Declaration.
