Survey. Sue C., the Elections Chair, reported on the results of the service survey. Announcements, Coordinator and Officer Reports

Literature Coordinator. Leigh spoke about the amount AIS is charging for literature. Currently, AIS does not charge for shipping and other related shipping costs, and therefore more is spent on literature than is made on the sale of literature. The consensus of the group was that this is OK. AIS is a service organization with its primary purpose being to provide the Al-Anon message to others. Distribution of literature to our members is one of the primary ways the message is distributed. The consensus of the group was that shipping charges and related costs were anticipated in the budget, and donations far exceed these expenses.

Assembly. Anne S. asked for volunteers to help with the hybrid portion of the Assembly meeting to be held in March.
