The audit is complete.

Cynthia V. dispersed amounts in excess of the "ample reserve." The "ample reserve" is defined as the amount covering four months of expenses and is currently set at \$10,000. For August, after paying for literature and other expenses, Cynthia V. distributed \$3,732.46 to the Arizona Area (75% of the excess amount above the ample reserve) and \$1,244.15 to the World Service Organization ("WSO"(25% of the excess amount above the ample reserve).

Elections. Kathy M. and the group discussed the following:

As the AIS chairperson, Kathy M. is completing her third year of service. According to the AIS Intergroup by-laws, she will be stepping down at the end of January.
