Southern Arizona Al-Anon / Alateen AIS Meeting Minutes

May 12, 2021

The meeting was called to order at 6:30 p.m. by Kathy with a moment of silence followed by the Serenity Prayer.

April Minutes approved by consent.

April Treasurer's report approved by consent.

7th Tradition Basket: Donate online or by mail.

Action Items

Election of Officers. Judith P. was elected Alternate Chairperson and subsequently resigned her position as 7th Tradition Coordinator. Kathy asked whether anyone was interested in filling the positions still open (Secretary, Office Manager, Archivist, Alateen Coordinator, 7th Tradition Coordinator, and Representatives for District 21, 23, or 25). The positions remain open.

Change to Article VI of Guidelines. The Steering Committee discussed the proposed change to Article VI of the Guidelines, which would allow At-Large Steering Committee members to be included as voting members at AIS. No recommendation emerged from the discussion. The committee decided to table the proposed change for now.

Financial Task Force Report. Kathy reported that the task force to define "ample reserve" and "operating expenses" met in April and will meet again after the tax season.

Postage for Literature. Kathy invited discussion on the question of whether AIS should continue to pay postage for the literature mailed to purchasers. Kathy began with a reminder that the new owners of the storage facility prohibit members from picking up purchased literature at the facility. As a result, literature is being distributed exclusively through the mail. It was pointed out that the budget for shipping costs (postage) is \$150 and that the actual year to date shipping costs (\$159.16) exceed the budget. Frank noted that the postage paid by AIS is approximately 10% of sales and that this cost to AIS is roughly offset by the 10% markup on purchases. There was general agreement to continue paying postage on purchased literature for the time being.

Other Topics of Discussion

SWACYPPA. Kathy reported receiving an email from SWACYPPA requesting assistance from AIS in the form of panelists, leaders and speakers. Debbie B. suggested that the request be sent to the Mary S., the Area Alateen Coordinator.

AIS Returning to In-Person Meetings. Christ Church has sent out COVID guidelines for the use of their facilities. The spacing restrictions for the room AIS has used might allow AIS to return to meeting in person. Julia C. pointed out that the guidelines required the submission of name and contact information, which is a violation of anonymity. Andrew raised the concern that members arriving after all the spaces are occupied would have to be turned away. Several members, noting their lengthy travel time to and from the church, expressed a preference to continue meeting on Zoom. Mike suggested that in-person meetings would still be preferable for special events (Bring a Friend, Elections, Founder's Day), but that ZOOM serves well for regular meetings. An informal poll was taken as to whether AIS ought to continue to meet on ZOOM. There were seventeen voting in favor of remaining on ZOOM, with one abstention.

AIS Office. Julia C. mentioned that a member of a group she attends was curious to know when AIS might reopen an office. Kathy suggested that AIS put off taking up that question until the Office Manager position is filled.

Officer / Coordinator / DR Announcements & Reports.

District 24. Julia C, Alternate DR, reported that the District will meet next month. The District is planning a roaming Area workshop on Sponsorship for Beginners. A few groups in the district are meeting in-person.

District 20. Ricki reported that the District is planning a pot luck fundraiser to help cover the cost of attending the convention.
