**Delegates Day June 1**. Judith P. reported that Delegates Day is being held in Tucson and that two family groups have agreed to host the event—the Steps to Freedom group that meets at 7:00 pm on Tuesday and the Sunday Morning AFG group that meets at 10:30 am on Sunday.

# **New Business**

**Storage Unit Clean Up.** Kathy M. reported that Michelle Y. and Dick B. were tasked by the Steering Committee to review the items in storage. After consulting with the persons who have items in storage (Literature Coordinator, Treasurer, and the former Archivist), Michelle Y. and Dick B. will have the discretion to decide whether a keep a particular item, donate the item or give or throw the item away. There was discussion regarding what items needed to be kept.

**Literature Procedures/Audit.** Cynthia V., the Treasurer, suggested that it would be best practice to have some written accounting procedures in place for literature sales, including reporting to the Treasurer before making purchases from WSO to make sure that AIS is able to maintain ample reserve funds at all times. Cynthia V. also suggested that it may be a good idea to audit a few selected literature items at least once a year. The group voted 15 in favor and 2 opposed to create a Thought Force to consider the matter and report back to the group. (Alice W. made the motion and Esta seconded the motion.)

**Insurance.** Cynthia V. reported that the insurance premium (approximately \$650) was due, and she questioned whether AIS needed as much insurance as it had purchased in the past now that it does not have a physical office. Cynthia V. will review the matter and report back to the group.

Changing Policy Restricting AA Members from Holding Service Positions Above the Family Group Level. There was discussion regarding whether AIS should take a position on this issue. The consensus of the group was that AIS is a literature distribution cent and not a governing body and should not take a position on the matter.

**Founders Day.** Kathy M. noted that she would like to discuss at the April business meeting whether AIS should have a Founders Day event in 2024.

**AWSC February 3 Meeting.** Julia C. thanked all the volunteers who helped make the meeting a great success..

**Literature Coordinator.** Leigh spoke about the need to add shelving to the storage facility. There was a motion to authorize Leigh to spend up to \$400 on new shelving. The motion passed with 17 votes in favor and 2 votes opposed. (Andrew made the motion and Julia seconded the motion.)
