# <u>New Business</u>

**Ice Cream Social.** Judith P. reported that the Steering Committee has proposed having an ice cream social, probably sometime in the summer, and there would be more information provided in the future about the event.

**12 Step Calls.** Autumn H. reported to the group on her work as the 12 Step Call Coordinator and the need to find volunteers to cover time periods to respond to 12 Step Calls. Autumn H. is developing a flyer for Alice W. to distribute to the AIS list encouraging members to volunteer to help with 12 Step calls. Autumn explained the 12 Step Call process, including the following information:

- A phone number is listed on the So. Ariz. AIS website for a person to call who needs support or has a question about Al-Anon. Calls made to the phone number are routed to a call center.
- The operator at the call center who receives the call then reaches out to the 12-step call volunteer assigned to the time slot and patches the caller through to speak to the 12-step call volunteer. The call center has a list of volunteers and does try to find a volunteer to speak with the caller before asking the caller to call back later.
- In responding to a caller, 12-step call volunteers convey Al-Anon's message of strength and hope, describe their general experience in Al-Anon, and offer family group meeting times and locations and information about literature.
- Any Al-Anon member can volunteer who has been a member of Al-Anon for one year and has a willingness to answer calls.

**Treasurer.** Cynthia V. reported that So. Ariz. AIS is doing well financially. Donations are up. All the budgeted yearly contributions to the Area and WSO have already been made and the reserve balance is back over \$10,000.

Alternate Chairperson. Kathy M. noted that she may cancel the Steering Committee meeting for May because she will be on vacation.
